## I. INTRODUCTION

**MAHATMA GANDHI POSTGRADUATE INSTITUTE OF DENTAL SCIENCES (MGPGI)** which was originally named as **PONDICHERRY DENTAL COLLEGE** has been established by Puducherry Administration in September, 1990 as an **AUTONOMOUS INSTITUTION OF THE GOVERNMENT OF PUDUCHERRY** and is administered by a duly constituted **BOARD OF GOVERNORS** headed by **Chief Secretary to Govt. of Puducherry as CHAIRMAN**. The Institution is functioning in its own building at Indira Nagar, Gorimedu, Puducherry and it is being developed as a centre of excellence in several specialities.

Within a short span, MGPGI has become the best institution in the Country under the Govt. Sector with well-equipped clinics and laboratories and strongly committed to maintain excellence in Dental Education and Research with the ultimate goal of achieving the status as one of the “Best Dental Institutions at the International level”.

The students who have passed out of this Institution are well placed at national and international levels.

The Institution has an excellent Library with a vast collection of foreign books and journals worth approximately ₹ 3.70 crores, authored by outstanding experts in the field.

**The Institution is recognised by the Ministry of Health and Family Welfare, Govt. of India, New Delhi on the recommendation of Dental Council of India, New Delhi** and has been accorded permanent affiliation to the Pondicherry University (A Central University).

The sanctioned intake for the under graduate (BDS) course is 40 seats under the following categories.

1 . Puducherry Domicile	- 29
2 . Non-Resident Indians / NRI Sponsored / OCI students	- 5
3 . All India Quota	- 6

The selection of the candidates under the Puducherry domicile category is made purely on merit basis by the **Centralized Admissions Committee (CENTAC), Govt. of Puducherry** based on the NEET – BDS marks.

The seats allotted under the All India Quota are filled in by the candidates sponsored by the Director General of Health Services (DGHS), Govt. of India through the Entrance Examination conducted on All India basis.

The admission under the NRI / NRI sponsored / OCI students are made purely on merit basis on All India NEET – BDS 2018 rank secured by the candidates.

The duration of the BDS course is five (5) academic years including one year paid Internship.

The BDS degree is awarded by the Pondicherry (Central) University after successful completion of the course.

The Institution is also offering Post Graduate courses (MDS Course) in the following specialities. The duration of the Post Graduate Course is three academic years.

- i) Prosthodontics & Oral Implantology
- ii) Oral Pathology & Microbiology
- iii) Oral & Maxillofacial Surgery
- iv) Oral Medicine & Radiology
- v) Conservative Dentistry & Endodontics
- vi) Periodontics

## **II . ADMISSION PROCEDURE :**

(a) Basic Requirements for Admission:-

1. Five seats (5) of the BDS Course at Mahatma Gandhi Postgraduate Institute of Dental Sciences (MGPGI) are permitted to be filled in by Non-Resident Indians / NRI sponsored / OCI students for the academic year 2018-2019.
2. Admissions under the above mentioned category are made by CENTAC to the I year BDS course based only on the NEET – 2018 marks obtained by the students. NRI / NRI Sponsored / OCI Students should have appeared for NEET (UG) - 2018.
3. The fee of the application form is ₹ 2500/- or equivalent in US Dollars by Demand Draft only.
4. All payments shall be made by crossed Demand Draft only, drawn in favour of **DEAN, MAHATMA GANDHI POSTGRADAUTE INSTITUTE OF DENTAL SCIENCES, PUDUCHERRY PAYABLE AT STATE BANK OF INDIA, PUDUCHERRY.**
5. The admission fee shall be US \$ 22,000.00 and amount should be paid in US \$ by Demand Draft only. Besides, the admission fee, annual tuition fee of ₹ 1.21 lakh (Rupees one lakh and twenty one thousand only) is payable every year. The admission Fee as well as annual tuition fee should be paid immediately when the candidate is selected for admission.
6. University Recognition fee / Examination fee / Development fee and Sports fee or any such other fee prescribed by the **Pondicherry Central University** shall be borne by the student.
7. **If any candidate fails to join the course or discontinues the course at any time after the last date of admission prescribed by the Dental Council of India / Hon'ble Court, the fees once paid shall not be refunded in any case and they will get their certificates back only after paying the fees for the remaining part of the course.**
8. Candidates should have completed 17 years of age as on 31-12-2018. No upper age limit is prescribed.

9. Candidates for admission to the BDS degree course under NRI / NRI Sponsored / OCI Students should have a pass in the Higher Secondary examination (Academic) conducted by the Board of Higher Secondary Examination of any State Board i.e. 12<sup>th</sup> standard or any other equivalent examination thereto as recognized by the Pondicherry Central University, candidate for admission to BDS course must have passed in the subjects of Physics, Chemistry, Biology & English individually and must have obtained a minimum of 50% marks taken together in Physics, Chemistry and Biology at the qualifying examination. **NRI / NRI Sponsored / OCI Students shall be treated as general category only.**
10. **Selection of Candidates for admission to B.D.S Degree courses will be based on the NEET SCORE only. The candidates are required to attach the Xerox copy of the NEET RANK and SCORE.**
11. The following certificates shall be submitted alongwith the application for admission.
- (i) Birth Certificates/SSLC Marklist/ Proof of Date of Birth
  - (ii) Higher Secondary Marklist / XII Marklist.
  - (iii) Transfer Certificate issued by the Institution last studied
  - (iv) OCI students should hold / produce valid visa obtained from the concerned Indian Mission abroad.
  - (v) Xerox copy of NRI Status Certificate of the Financial Supporter issued by the embassy of respective country under their seal.
  - (vi) NRI Bank Account Pass Book of the financial supporter.
  - (vii) Passport of the Financial Supporter.
  - (viii) Nativity Certificate of Financial Supporter.
12. The application in the prescribed form complete in all respects alongwith copies of all certificates/documents should reach the office of the Dean, Mahatma Gandhi Postgraduate Institute of Dental Sciences, Indira Nagar, Puducherry-605 006, on or before **18.07.2018** by 5.00 pm.
13. Applications which are incomplete, defective or received after the due date shall summarily be rejected and no correspondence shall be entertained in this regard.
14. It would be convenient if the candidates arrange themselves to receive any communication by post in India.
15. OCI students shall follow the directions issued by the Govt. of India from time to time wherever applicable to them.
16. Candidates provisionally selected for admission shall be intimated by post. No communications shall be sent to the applicant not selected and no correspondence in this regard shall be entertained.

17. The candidates who are provisionally selected should bring all certificates / documents in original at the time of admission, failing which the provisional admission offered shall be cancelled. Candidates are advised to take enough numbers of photocopies of the documents before submitting the original documents to this institution.
18. All admissions made are provisional and subject to the approval of the Pondicherry Central University.
19. The candidates may be called for counseling if necessary. Having been called for admission/counseling does not necessarily mean acceptance of eligibility for admission.
20. Candidates who are provisionally selected for admission should themselves get medically examined by the Medical Board, Mahatma Gandhi Postgraduate Institute of Dental Sciences, Puducherry and produce a Medical Fitness Certificate in original at the time of admission.
21. The classes for I BDS Course shall commence from 2<sup>nd</sup> week of August 2018 (subject to change).
22. The Institute has excellent hostel facilities for boys and girls separately. Hostel accommodation will be subject to availability of accommodation for which Hostel fees shall be paid separately.

### **Note:**

Candidates shall themselves ensure that they are eligible for the admission before the application is submitted. The admission of any candidate not possessing the required and recognized qualification either based on false certificates or by oversight shall be liable to be cancelled and the candidate shall have no cause for grievance.

Any seat left unfilled due to non availability of candidates, under NRI / NRI Sponsored / OCI category will be transferred to General Category of the Pondicherry domicile by CENTAC, Puducherry after getting approval from Competent Authority.

### **III. WARNING**

In case any candidate is found to have supplied false information or certificate etc., or is found to have withheld or concealed information in his / her application form, he / she shall be debarred from admission and if already admitted, the admission will be cancelled without prejudice to other disciplinary action.

### **IV. DISCIPLINE**

- i. The Institution aims at maintaining the highest standard of discipline amongst the students. The students should abide by any general or special rules prescribed by the Institute in regard to discipline and conduct from time to time.
- ii. All students shall attend Seminars / Lectures / Discussions / Clinics / Lab etc. regularly and obtain minimum attendance as prescribed by the Pondicherry Central University.

- iii. Students shall not associate themselves with any political party or organization within or outside the Institute campus.
- iv. Use of alcohol and intoxicating drugs & smoking inside the Institute is strictly prohibited.
- v. Students shall desist from agitations and demonstrations.
- vi. Every student shall carry an Identity Card issued by the Institute.
- vii. Any act of disobedience or misconduct will be dealt with seriously by the Institute.

#### **PROGRESS IN STUDIES :**

Students are expected to keep steady progress in their studies. If a student is found to be indifferent in studies or his / her attendance is poor, he / she may face disciplinary action from the Institute or may be detained from appearing in the University examination.

#### **RAGGING STRICTLY PROHIBITED:**

**Ragging is strictly prohibited.**  
“If any incident of ragging comes to the notice of the concerned authority, the student shall be given liberty to explain before a committee and if his / her explanation is not found satisfactory, the authority / committee would suspend / expel him / her from the institution”, and also other legal action shall be initiated as per the directions issued by the Hon’ble Supreme Court of India / Government / DCI from time to time, if necessary.
