(This shall be a recognized dental qualification when granted by Pondicherry University, Pondicherry in respect of the MDS students of Periodontology with two seats being trained at Mahatma Gandhi Postgraduate Institute of Dental Sciences, Puducherry, on or after 26th March, 2013)"
